1. Introduction

This Notice of Proposed Amendment recommends changes to GAR 39.59 to simplify compliance with GAR 39.9 (k) through the use of a fixed Approval Conditions Supplement instead of a template tailored by the Approval Validation Holder

2. Consultation Categories

This Notice of Proposed Amendment is offered to interested parties for both information only. The proposal in this NPA falls into category 1.

Category 1: Information only. This applies to those proposals that would have no material impact on interested parties, or codify policies and practices that are already in use, or are adaptations to external developments that cannot be influenced by Guernsey.

It is proposed that Option 1 organisations that are currently validated will continue using their existing supplement until their renewal. New applicants will be validated using the fixed Approval Conditions Supplement from the date of implementation of this change 1st January 2026.
